Product identification: Effisus ProFlex FR is a multi-layered weatherproofing membrane composed by a robust double side fire retardant polymer and fire retardant ultra-elastic reinforced core.



Product description: The weatherproofing membrane Effisus ProFlex FR is a high-tech, multi-layered weatherproofing membrane, designed for managing water, air, water vapour and moisture. This membrane combines a 200% elongation capacity and a Class B-s3, d0 fire reaction rating (EN 13501-1). Developed for sealing façade interfaces and construction joints on typical curtain walls, on rainscreen/brick ventilated facades, precast, masonry and many other applications. Intended use: EN 13859-2:2010. Width on a reel: Bespoke. Thickness: 1 mm.

Manufacturing process: The manufacturing process of Effisus ProFlex FR membrane involves an innovative bulk-forming process, resulting in a multi-layered weatherproofing membrane composed of a robust double-sided fire-retardant polymer and a fire-retardant ultra-elastic reinforced core.

Geographical scope: Global

Raw materials are supplied from outside Europe (USA and Singapore) and Portugal. The products studied are produced in Portugal but can be used on a global scale.

Name of manufacturer(s), if different from the EPD owner: The product manufacturer is different to the EPD owner. Product manufacturer is located in Portugal as specified in the company information section.

Content declaration

The product does not have any dangerous substances from the candidate list of SVHC for Authorisation. According to the CLP regulation (EC No 1272/2008), a category 2, H351 carcinogenicity level is declared in the product safety data sheet, and stannine dichloride in the membrane has a EUH208 hazard statement. However, although the product is classified as hazardous, a hazard warning label is not required. According to Annex I, subheading 1.3.4. of CLP Regulation (EC) No 1272/2008, the product consists of a mixture containing elastomers or polymers and has been shown not to present a danger to human health or the environment in the form in which it has been marketed.

The results are calculated using the average values for the weights of the components.

LCA information

Declared unit: 1 m² of Effisus ProFlex FR membrane with a density area of 1150 g/m² and 1mm of thickness.

Reference service life: no applicable.

Time representativeness: All specific data related to the production plant and used for the study dates from 2024.

Database(s) and LCA software used: The secondary data has been extracted from the Ecoinvent v3.11 database, included in the SimaPro v9.10 software and internationally recognized. Wherever possible, inventory data relating to the specific study countries, or in their absence from Europe in general, has been selected. These have been used for the stage of production and transport of raw materials, as well as for electricity generation or waste management processes, over which the manufacturer has no direct influence.

Description of system boundaries: This EPD represents a cradle to gate with modules C1–C4 and module D (A1–A3 + C + D).

The distribution stage (A4) is not covered by the LCA as the clients are very scattered geographically, causing potential distribution impacts to suffer great variations depending on each location and any average value given for the A4 module to carry great uncertainty and not represent useful information. The installation module is also excluded as installation impacts are deemed negligible. Finally, the use stage is not included as membranes have no operational impacts.

Applicable lifecycle stages with the system boundaries and processes are described below.

- **Raw materials supply (A1):** This module considers the extraction and processing of raw materials used for the manufacture of the membrane.
- **Transport (A2):** This module consists of the transportation of the raw materials to the manufacturing plant.
- **Manufacturing (A3):** This module includes the impacts associated with the manufacturing of the membranes in the suppliers' installations including the product packaging, the burning of fuels, and the treatment and transport of the waste generated throughout the manufacturing process of the products. Regarding electricity consumption, the following mix has been modelled corresponding to the mix as purchased to the electricity supplier in the production plant in Portugal. The climate impact of this mix is 0.236 kg CO₂ eq./kWh (using the GWP-GHG indicator).

As a trader EPD, module A3 also includes the transportation of the finished product from the supplier's installations to Effisus's warehouse in Portugal. Note the membranes do not require special storage conditions, leading to impacts from the warehouse to be negligible. No additional packaging is required either, given that the warehouse receives packaged products.

- **Deinstallation (C1):** This includes the deconstruction/demolition of the membranes, which are adhered to a house's walls, considering diesel as an energy carrier as specified in the PCR for construction products, v2.0.1.
- **Transport to the waste processing site (C2):** Transport of the product as waste at the end-of-life to the treatment facility.

- **Waste processing (C3):** Impacts for C3 are zero as no materials in the product are recycled.
- **Disposal (C4):** This module includes the final discharge of waste that has not been destined for recovery or treatment processes. In this case, this includes the whole weight of the product.

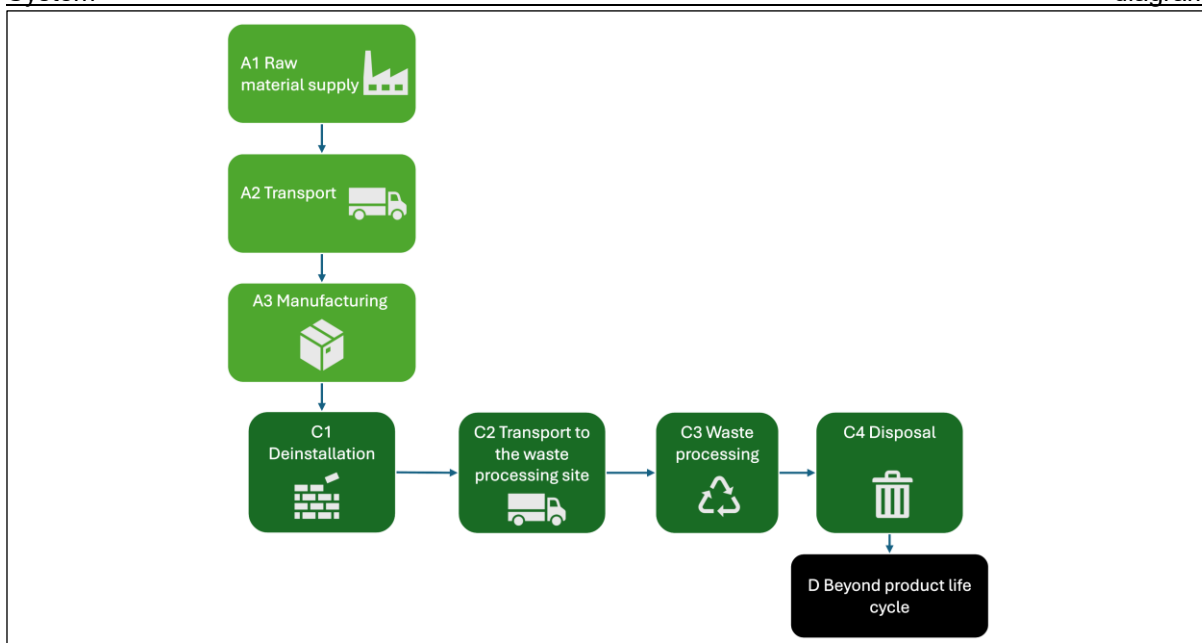

- **Beyond product life cycle (D):** No recycling of the membranes at end-of-life is considered as the product is not recycled or reused due to a lack of technical and economic viability, therefore, impacts for module D are zero.

Infrastructure and capital goods for upstream, core and downstream processes have been excluded.

Allocation procedures

- The electricity consumption of the product has been calculated using a mass allocation, by dividing the total electricity consumption of the production plant by the total kg of product produced.
- For the rest of the production plant energy consumption as well as for water consumption and waste produced a mass allocation was used.

Data quality requirements

This EPD is based on data collected by EFFISUS, UNIPESSOAL Lda. from the Portugal plant. The EPD covers a product named Effisus ProFlex FR.

Data quality requirements established by ISO 14025 standard, PCR 2019:14 Construction products, version 2.0.1 and UNE-EN 15804:2012+A2:2020 have been applied. The technological, geographical, and temporal coverage of the primary data has been evaluated through a data quality assessment of generic and specific data defined by the PEF on LCA database development as described in Annex E.2 of the UNE-EN 15804:2012+A2:2020 standard. As a result of the data quality matrix, it is quantified that the gathered data achieves a medium level of quality (3.92 out of 5) in a range of very poor (1), poor (2), medium (3), good (4) and very good (5).

The quality of the data used to calculate this LCA meets the following requirements:

- Used background data are of recognised prestige and acceptance in the technical and scientific fields. In particular, the Ecoinvent v3.11 database, the most recent version existing at the time of the study, is considered to be of preferential use.
- Regionally specific datasets were used to model the energy consumption (electricity or natural gas). For the processes of transport, production of raw materials or end-of-life, datasets were chosen according to their technological and geographical representation of the actual process.

Furthermore, certain quality limitations have been identified because of database constraints:

- Some of the datasets employed for the modelling of waste treatments within A1 have poor geographical representativeness. However, given the relevance of plant waste treatment, their contribution to the overall impacts is minimal.

Hypothesis and considerations applied

The main assumptions made in the study are the following:

- The production data used in the study corresponds to the year 2024
- For electricity consumption, other plant resource uses, and waste generation, a mass-based allocation was performed, expressed per kilogram of product produced during the study year.
- The electric mix for the manufacturing plant is an adaptation of the country mix ecoinvent dataset of Portugal to reflect energy source purchased for the plants.
- The raw materials are transported by truck, ship and aircraft from the supplier to the production plants. The specific distances have been considered for each supplier and material, distinguishing between transport type.
- It has been assumed that all truck transport complies with the EURO 6 emission regulations, as it takes place within European territory.
- The secondary and third packaging used to distribute the products from the manufacturing plants to EFFISUS is assumed to be the same that will be distributed to the final clients.
- A treatment method has been assigned to each type of waste generated at the production plant based on the waste management procedures provided by the supplier. For the distribution of each treatment type by waste category, data from Eurostat (Eurostat, 2022) were consulted. When multiple treatment options are available for certain wastes and no specific information is provided, the most conservative approach has been adopted.
- It is assumed that there is 50 km between the production plant and the waste treatment plant, and waste is transported by a 16-32 metric ton truck.
- It is assumed that the raw materials are transported from suppliers to a warehouse in Portugal by a >32 metric ton truck.
- Figures for demolition are obtained from the updated PCR for construction products, v2.0.1.

- A default distance of 80 km between the building site and the waste manager facility is assumed, and product waste is transported by a 16-32 metric ton truck.
- For the end-of-life, landfilling within the European region is assumed.
